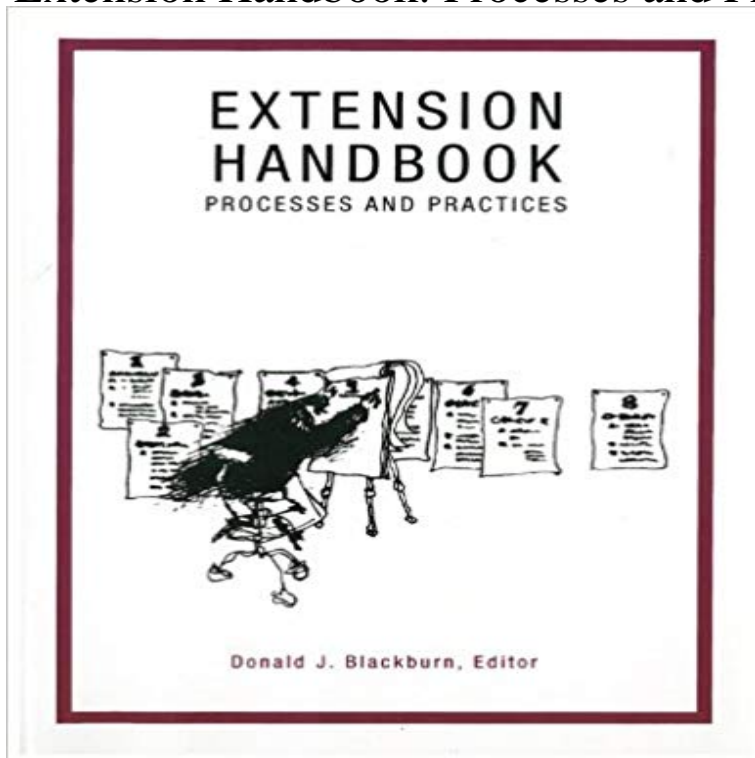


Extension Handbook: Processes and Practices
