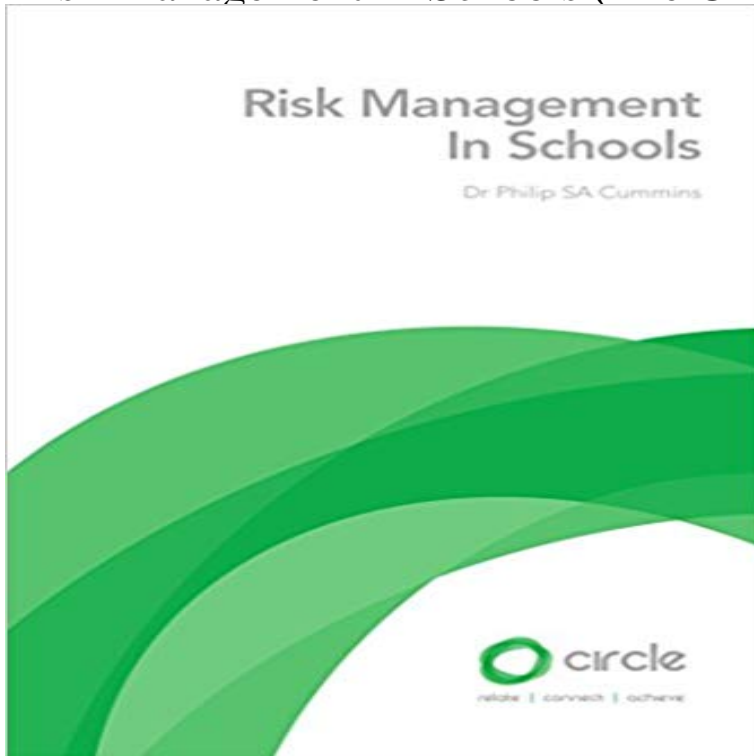


Risk Management In Schools (The CIRCLE Evaluation Series Book 2)

The concept of risk in schools is not a fad: the risk movement is important and is not going away. Schools must be thinking about developing strategic processes that foster an understanding of risk management as being the natural outcome of a professional school culture. There are many approaches to risk management. This book advocates a whole school approach, led by the School Board and Principal, with structured processes and a clearly defined framework. It champions a view of risk whereby regular review is inherent within the school operations and culture.
