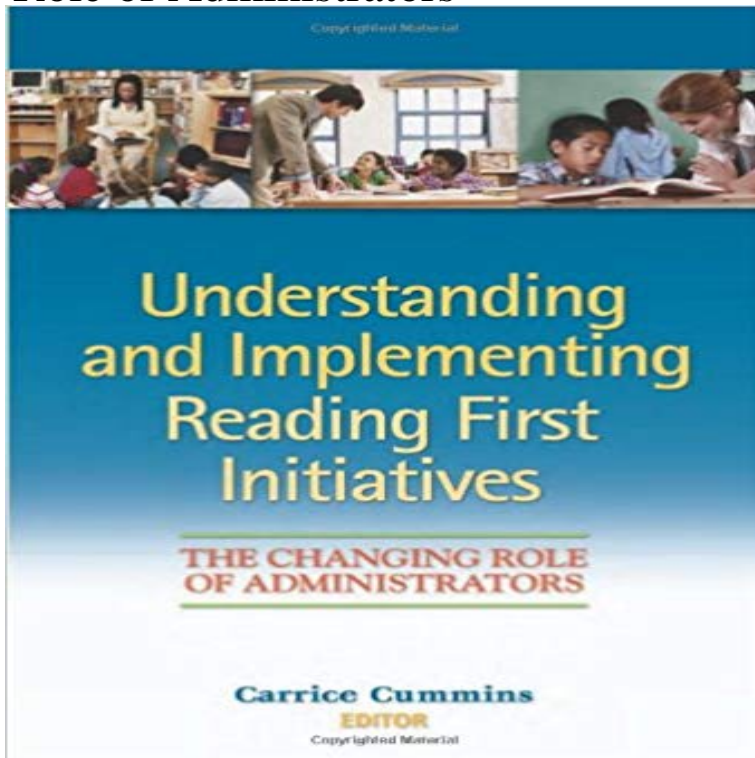


# Understanding and Implementing Reading First Initiatives: The Changing Role of Administrators
